Remita Collection	*Access the e-collection Platform via www.remita.net. *Click "PAY A FEDERAL GOVERNMENT AGENCY" *Enter "COUNCIL OF LEGAL EDUCATION" *Enter other payment details as required. *Select any preferred electronic payment channels (Card, Internet banking, mobile Wallet, POS etc) to complete your payment.

Payers will be issued an electronic receipt following payment, which should be taken to Accounts Department of Nigerian Law School Headquarters or the Campuses to convert into an official receipt to receive applicable service. (Note Your Remita Retrieval Reference RRR):
